ZIL's concerns

Un-integrated systems

ZIL already had a few information systems deployed at their production and quality control level but the efficiency rate was low due to non integration of the systems. The management was especially concerned about the yield reports. With the information system they currently had, a uniform access was not possible. And ensuring quality and accuracy of production data was proving to be a futile effort in the absence of end-toend information systems.

Further, ZIL needed to find a way to monitor the sales and claims of their nation-wide distributors whose numbers ranged around 400.

The ERP search

In 2004, the search was on for an ERP

solution that would automate and streamline the critical business processes for ZIL.

The first option was to consider foreign solutions being provided by companies like SAP and Oracle. Though the foreign solutions catered to many large industries, but the high cost and culture misfit were a cause for concern. It was important that the chosen solution should align with the specific business requirements of the local industry. And, ZIL was wary of being trapped by a large scale, high-cost and complex enterprise software implementation.

The Implementation


The implementation process started immediately and the SigmaTec team started working on providing additional customization required by ZIL, the necessary development and deployment.
